Quick Review

A firsthand account is told by someone who was there. It includes feelings and personal details. A secondhand account is told by someone who studied the event later. It focuses on facts and the big picture.

PART 1 — READ

Read the passage. Then answer the questions.

Two Views of the 1906 San Francisco Earthquake

Account 1 (Firsthand): From the diary of Anna Lin, age 12, written April 19, 1906.

I woke up before the sun. The whole bed was shaking, and I thought my brother was playing a trick on me. Then I heard our dishes crashing in the kitchen and Mama yelling for us to get under the doorway. The floor moved like a wave. My doll fell off the shelf and her head rolled across the room. Outside, the chimney from Mr. Halloran's house had broken off and was lying in the street, smoking. I could smell something burning. Mama said we had to walk to the park because the buildings might not be safe. We took only one bag and the cat. People on Market Street were quiet, like they did not know what to say. I held Mama's hand the whole way.

Account 2 (Secondhand): From a children's history book published in 2018.

On April 18, 1906, a powerful earthquake struck San Francisco, California. Scientists today estimate that it measured about 7.9 on the moment magnitude scale, making it one of the strongest quakes ever recorded in the United States. The shaking lasted about forty-five seconds and damaged hundreds of buildings. Even worse, broken gas lines started fires across the city. Because so many water pipes were also broken, firefighters could not put the fires out. Over the next three days, the fires destroyed more than 28,000 buildings. About half of the city's 400,000 people lost their homes. The disaster led California and other states to pass new laws requiring stronger building designs in earthquake zones.

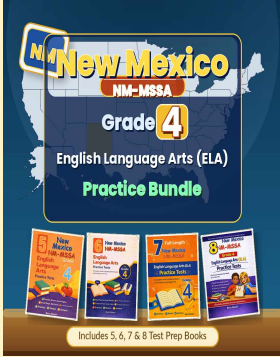

Explanations	
1. A	Personal pronouns from a witness are the strongest firsthand clue. B is true (the date helps) but a secondhand source can also include a date. C is true of both accounts. D is about style, which is not a reliable firsthand sign.
2. D	Being written long after AND giving city-wide statistics together signal a secondhand history source. A and B are true of both accounts. C describes Account 1 (firsthand), not Account 2.
3. C	The doll is a small personal moment — only a firsthand witness would record it. A, B, and D are city-wide facts from the history book.
4. B	An exact duration like "forty-five seconds" is the kind of measurement a history book adds later. A, C, and D are personal-moment details from Anna's diary.
5. A	Firsthand accounts share feelings as the event unfolds. B gives a number, not feelings. C also gives a number. D names a date but not a feeling.
6. C	City-wide totals are in Account 2. A and B describe one block of one street. D is wrong — the accounts focus on different scales.
7. B	Anna sees a broken chimney; the book says 28,000 buildings were destroyed. Both show damage. A, C, and D are precise facts from Account 2 only — Anna does not give the magnitude, the fire's length, or the laws.
8. D	D names the real difference. A flips them around. B is unfair to historians — secondhand accounts are not "usually wrong." C contradicts the differences shown.
9.	Answer: Sample answers: (1) Account 1 says "My doll fell off the shelf," showing a personal-moment focus. Account 2 says "the fires destroyed more than 28,000 buildings," showing a big-picture focus. (2) Account 1 says "I held Mama's hand the whole way" (feelings/relationships); Account 2 says "about half of the city's 400,000 people lost their homes" (city-wide statistics). NOT acceptable: picking two details from the same account, or labeling both as the same focus. Strong answers pair a personal detail from Account 1 with a city-wide fact from Account 2 AND name each focus (personal/feeling vs. wide facts/context). Reject answers from one source only or with matching labels.
10. A	Anna smells smoke right after the quake, which fits Account 2's claim that broken gas lines started fires across the city. B, C, and D are personal moments unrelated to the cause of the fires.
