## Quick Review

A pronoun must match its antecedent in number and gender. SUBJECT case (I, he, she, we, they, who) is used as the doer; OBJECT case (me, him, her, us, them, whom) is used as the receiver. Possessive 'its' shows ownership; 'it's' = 'it is'. To check 'who/whom', try 'he/him': if 'he' fits, use 'who'; if 'him' fits, use 'whom'.



### Explanations

| 1. D | Both pronouns are SUBJECTS of 'went', so both must be in subject case: 'He and I'. A uses object case for both. B mixes object 'him' + subject 'I'. C uses subject 'He' + object 'me'. Trick: drop one name and re-read — 'Me went' / 'Him went' immediately sounds wrong.   |
| 2. B | 'Each student' is SINGULAR, so the pronoun must be singular: 'his or her'. A uses plural 'their' (informal but flagged on tests). C uses subject pronoun 'they' as a possessive. D confuses 'it's' (= it is) with the possessive 'its' AND uses 'it' for a person.   |
| 3. A | 'To ___' takes the OBJECT pronoun 'whom' (give it to him → to whom). A is correct. B uses subject 'who' after the preposition 'to'. C uses subject 'who' as the object of 'to'. D uses object 'whom' as the SUBJECT of 'should give' (must be 'who').  |
| 4. C | Possessive 'its' has NO apostrophe. C is correct. A uses 'it's' (= 'it is'). B invents a nonexistent form 'its'. D uses plural 'their' for one puppy (number mismatch).  |
| 5. D | Marcus and ___ are OBJECTS of 'gave' → 'me'. D is correct. A and B use subject 'I' as an object (drop 'Marcus and' → 'gave I'? — no). C misuses the reflexive 'myself', which only works when the subject and object are the same person ('I gave myself...').   |
| 6. B | When 'neither X nor Y' joins one female and one male antecedent, modern usage accepts singular 'their' for the mixed pair. A picks only the male; C picks only the female; D uses 'its' (for things or animals, not people).   |
| 7. A | After a preposition like 'between', use OBJECT pronouns: 'you and me'. A is correct. B uses subject 'I' after a preposition. C misuses reflexive 'yourself'. D uses subject 'we' after a preposition.  |
| 8. C | 'She' in A and B could refer to either Maya or Lily — ambiguous. D uses TWO unclear pronouns before naming anyone. C repeats the name 'Maya' so the reader knows exactly who was excited.  |
| 9. D | 'We players' is the SUBJECT of 'were' → use subject case 'we'. D is correct. A and C use object 'us' as the subject (drop 'players' → 'us were excited'? — no). B uses 'we' for the OBJECT 'coach' ('meet we coach' is wrong).   |
| 10.  | <b>Answer:</b> She and I walked to the store, and the clerk gave Jamal and me free samples. Two fixes needed: (1) 'Her and me' are SUBJECTS of 'walked' → 'She and I'. (2) 'Jamal and I' are OBJECTS of 'gave' → 'Jamal and me'. Mark wrong if either fix is missed, or if the student writes 'myself' (reflexive misuse) or 'her and I' (mixed case). |
