## Quick Review

#### School Start Times: A Complicated Change

Many sleep researchers argue that middle schools should start later because adolescent sleep cycles shift naturally. Students who sleep longer tend to show better attention, mood, and attendance.

The author acknowledges that later starts create real problems. Bus routes may need to change, after-school sports can run later, and families may have to adjust work schedules.

However, the author argues that those problems are logistical rather than biological. Districts that pilot later starts can redesign bus tiers, coordinate athletic schedules, and survey families before making permanent changes.

The article concludes that inconvenience should be weighed honestly, but it should not be treated as stronger evidence than research on student health and learning.



### Explanations

8. D	This detail is specific enough to support analysis in a written response.
