## Quick Review

Evaluate whether evidence is relevant and sufficient. A claim may sound strong but still fail if the support is unrelated, too narrow, or misleading.

## Should Cities Ban Single-Use Plastic Bags?

A student editorial claims that the city should ban single-use plastic bags at grocery stores. The editorial argues that plastic bags often end up in waterways, where they break into smaller pieces that wildlife may swallow.

The editorial cites a local cleanup report showing that volunteers collected 18,000 plastic bags from riverbanks in one year. It also cites a store survey showing that shoppers adapted quickly when a neighboring city charged a small fee for bags.

One paragraph weakens the argument by adding that the writer dislikes the color of most plastic bags. Another paragraph is stronger because it explains that reusable bags must be washed and used many times to be the better environmental choice.

The best argument is not the loudest one. It is the one that uses relevant evidence and admits complications honestly.



### Explanations

1. B	The correct evidence directly proves the stated inference rather than merely mentioning the same topic.

It supports the statement with a precise detail such as: Volunteers collected 18,000 plastic bags from riverbanks in one year. Use exact wording from the text or task, then explain your reasoning.
