## Quick Review

In nonfiction, words can carry technical meanings and connotations. Use context to decide what a word means and why the author chose it.

#### Engineering a Quieter City

City noise is more than an annoyance. Constant traffic, construction, and sirens can raise stress levels and make it harder for residents to sleep or concentrate.

Engineers call the problem acoustic load: the total amount of sound pressure a place carries over time. A single loud horn may be brief, but a steady wash of engines can create a heavier load than people realize.

Cities reduce acoustic load in several ways. Some use rubberized asphalt that absorbs tire sound. Others plant dense rows of trees, build low sound walls, or change delivery schedules so trucks do not idle under apartment windows before dawn.

The goal is not silence. A healthy city still hums with people, transit, and work. The goal is to keep that hum from becoming a weight residents must carry all day.



Explanations	
<b>1. B</b>	The correct evidence directly proves the stated inference rather than merely mentioning the same topic.
<b>2. A</b>	The correct answer covers the whole passage, while the distractors are too narrow, too extreme, or unsupported.
<b>3. C</b>	The context around the word points to this meaning in this passage.
<b>4. D</b>	The correct answer explains the role the detail plays in the development of the text.
<b>5. B</b>	The correct conclusion follows from multiple details, not from a single isolated word.
<b>6. A</b>	A strong summary includes the main conflict or idea and the outcome without personal opinion.
<b>7. C</b>	This choice overstates or invents an idea that the passage does not prove.
<b>8. D</b>	This detail is specific enough to support analysis in a written response.
<b>9.</b>	<b>Answer:</b> A strong response quotes or closely paraphrases: Constant traffic, construction, and sirens can raise stress levels and make it harder for residents to sleep or concentrate. Then it explains how that detail proves the inference instead of only repeating it. Use exact wording from the text or task, then explain your reasoning.
<b>10.</b>	<b>Answer:</b> A strong response states: Cities can reduce harmful noise by treating sound as an engineering problem and designing streets and schedules more carefully. It supports the statement with a precise detail such as: Constant traffic, construction, and sirens can raise stress levels and make it harder for residents to sleep or concentrate. Use exact wording from the text or task, then explain your reasoning.
